



## Privacy Policy

Dear sir/madam, we wish to inform you that the Legislative Decree n. 196 of June 30th, 2003 (“Code regarding the protection of personal data”) provides for the protection of persons and other subjects regarding the processing of personal data. According to the law, this treatment will be based on principles of correctness, lawfulness and transparency and the protection of your privacy and your rights.

Under Article 13 196/2003 IL MIGLIO BLUE DI ALOSI CRISTOFORO is required to provide some information about the use of the personal information you provide or that we acquire in the future, during the term of our contractual relationship.

### 1. PURPOSE AND METHOD IN WHICH DATA ARE PROCESSED

The processing of data you bestow is acquired by writing, computer and telephone, with logic and method strictly related to the purpose of recruitment or for one or more working relationship with the company over time. The data will be processed in accordance with the rules of confidentiality and security required by law, even in the case of communications to third parties. The processing of the data you supply may also include the category of “sensitive” data. However, include only the data you want to be known and follow the procedure. In particular, it is recommended to not enter data related to political, religious, or trade union beliefs or similar strictly private or confidential information.

### 2. MANDATORY BESTOWAL OF DATA AND CONSEQUENCES OF FAILURE TO RESPOND.

The data you provide are mandatory in order to carry out the operations referred to in paragraph 1. Lack of acceptance and the subsequent lack of authorization to process the data makes it impossible for IL MIGLIO BLUE DI ALOSI CRISTOFORO to take into consideration your request

### 3. COMMUNICATION AND DISSEMINATION

Your data may be communicated to employees of IL MIGLIO BLUE DI ALOSI CRISTOFORO in charge of processing the data for functional purposes, as well as to employees of related companies for purposes related to your request, and for statistical purposes.

### 4. YOUR RIGHTS

Article 7 of d.lgs.196/2003 attributes the following rights:

- a) to obtain the confirmation of the existence of your personal data, even if not yet registered, and their communication in an intelligible form.
- b) to obtain the origins of your personal data, the purposes and the methods of their processing; the logic applied in the case of processing done by electronic means; the identity of the owner, manager, and persons or group of persons to whom the data may be communicated or who could become aware of the data as managers or agents.
- c) to receive the update, the rectification or the integration of data; their deletion, transformation into anonymous form or their blocking for data processed in violation of the law; the evidence that such operations were made aware to those in which their data were communicated or disseminated.
- d) to object to the processing of personal data for justified reasons or in cases in which they are used for advertising, direct marketing, or the completion of market surveys.
